**Proceedings:**

1. **Meeting started** with recitation from Holy Quran by Mr. Muhammad Ali.
2. **Minutes of 5<sup>th</sup> meeting** held on May 10, 2008 were read out and confirmed.
3. **Monthly account statement** for May 2008 was discussed and approved.

5. Reports from various sub-committee chairmen were received, discussed and adopted.
- 5.1 Mr. Muhammad Ali was appointed chairman of new membership sub-committee.
- 5.2 Mr. Aqeel Muhammad Zawar, chairman, sports & culture sub-committee, was desired to organize a cricket match with North Karachi Association of Trade & Industry.
- 5.3 Mr. M. Farooque Bakaly, chairman, power & gas sub-committee complained about non-receipt of daily complaints and attendance sheet of KESC complaint centre. The complaint supervisor Asif Siddiqui has promised to maintain it quite regularly.  
  
Mr. Bakaly was badly disturbed about the fate of his application for DSL connection, which was pending since March 2008. Secretary was desired to take up the matter with higher-ups and get it installed at his earliest.
- 5.4 Mr. Shahid Ismail was demanding to take up the matter of imposition of 35% LC margin, which was quite unjustified and to be abolished.
- 5.5 About the visit of electrical inspector, the matter was decided to be taken up with Industries Minister by inviting him at the Association.
- 5.6 Mr. M. Idrees Gigi being the chairman of law & order sub-committee desired the Secretary to hold a meeting with the bank managers of this area to follow-up the proceedings of an earlier meeting of Town Police Officer at the Association secretariat. The 12<sup>th</sup> instant was thus fixed the date for such meeting.
- 5.7 Mr. Idrees Gigi in his capacity of the chairman, Building Project sub-committee informed the House that Mr. Akhtar Lakhani has shown his inability to finance our building project because of his present circumstances. He has therefore approached financial institutions including Emirates Global Islamic Bank for this purpose and hope for the better.
- 5.8 It was desired that one representative from Federal B. Industrial Area should be got appointed at Labour Minister's committee.
